Due to our efforts to address environmentally hazardous substances, we will be changing the resin used for the cases and bottom covers of certain photointerrupters from PFAS-containing to PFAS-free.

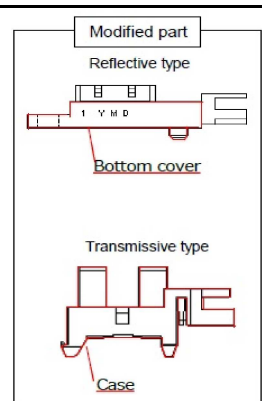
Reflective type models :
